## Year 12 Biology

## Keys for Life - Perfect Results



Our Yr 10's have been taking part in the Keys for Life Programme run by Mrs Riseley and the Year 10 Pastoral Care Advisors, Mrs Blyth, Mr Snashall and Mrs Koshy. Students spent semester 1 learning about the road rules, driver safety, the effects of drugs and alcohol when driving and various others topics related to driving. The purpose of this endorsed program is to prepare young people for life on the road. We have had police talks and visits from RAC speaking to the students about driver safety. To be eligible to sit their learners test they must first complete all in school and at home tasks. They have recently sat the test with Dannielle Smith, Thomas Piotrowski, Takara Smyth and Bailey Artemis achieving a perfect score! 21 out of 24 students who sat the test passed A second test will take place next term. Well done to our year 10s.

## Year 6 Fremantle Trip

What an end to the semester! A recurring focus throughout Semester One was the many different migration stories of people moving to Australia. The topic as a whole was taught in Humanities and Social Sciences, with parts lending themselves to writing in English. This culminated in our Year 6 trip to Fremantle. Our visit to the Maritime Museum allowed us to relive the memories of 6 migrants to Australia. We discussed what sorts of challenges they would have endured, we looked and handled some of their personal items; and finally, we looked at their personal contribution to the development of Western Australia.

The migrants we learnt about were Stephen Anstey (1968 - England), Ilona Hrubos (1951 - Czechoslovakia), Yasukichi Murakami (1897 - Japan), CY O'Connor (1891 - Ireland), Nonja Peters (1949 - Holland) and Giacomo Iannello (1900 - Italy).

After a short bus ride, we found ourselves at the stone gates of Fremantle Prison. We wandered through the old gaol in awe of the construction and trying to imagine the conditions. To their horror, our pupils listened to stories about solitary confinement and floggings. We also learnt about the types of jobs convicts were given which contributed to the landscape of Fremantle as we know it today.





## PRIMARY NEWS

### STUART LEARMONTH HEAD OF PRIMARY



It's hard to believe that we have hit the mid-point of the year already. As always, we have had a fun-packed and learning-filled few weeks in the life of the Primary School. With *Shrek the Musical* coming soon, our assembly plans have changed slightly so it has been lovely to have quite a few assemblies in succession. I say this regularly, but assemblies are one of my favourite things that happen in a school. Seeing children express themselves and put themselves out there in ways that we do not normally see is always beautiful to observe.

### End of Semester Reports

As we end the semester and begin the holidays, you will receive your child's Semester One report. This will be posted during the holidays. These go to all Kindergarten to Year 6 students.

When putting reports together, staff take on board many different aspects of learning. Report grades and comments are based upon day-to-day learning activities, formal and informal assessments, discussions, observations and ongoing teacher judgement. Teachers also use something called Judging Standards. These are produced by the *School Curriculum and Standards Authority (SCSA)*. In essence, the Judging Standards allow teachers to compare student assessment work with what is judged to be a satisfactory, benchmarked standard across the state and country. This satisfactory level equates to a 'C' grade. We also use Judging Standards to ally student learning to all other grades; however, it must be remembered that a 'C' grade is a solid grade which should be celebrated. Most schools use this framework when formally assessing student learning as grades cannot and should not just be plucked from thin air so-to-speak.

As you are aware, we send home our Learning Journey Folders in the penultimate week of each term. The work samples and assessments within these folders are often day-to-day work samples so that you can see exactly what your child is producing and learning. There are also work pieces in these folders that are formal and informal assessments which have been marked in accordance with the Judging Standards.

Where a child is not achieving the satisfactory, benchmarked standard for a particular core subject across the Semester (Mathematics, English, Humanities and Social Sciences and Science), we feel it is the best course of action to alert parents and caregivers to this before the report goes home. This is standard practice in most schools. In some cases, where students are achieving below the benchmarked standard, a short and sharp burst of intervention can help to raise this. In other cases, children may need a Curriculum Adjustment Plan to identify particular areas of development. However, it can sometimes be the case that this is the maximum level that your child has reached, and this is fine. As a School, we promote and develop the whole child, not just the development of curriculum content and skills. This is why we spend so much time and effort on putting together the left-hand side of the report which details and celebrates work habits and attitudes towards learning.

I hope that you have a lovely break with your families and I look forward to welcoming all of our students back after a much-deserved break.







## Try a Trade

Try A Trade was another experience that our several of our students were involved with this semester. Christian Inglis-Hodge, Caleb Ramsay, Hugh McKay, Leroy Pascoe, Zak Marsden and Jye McMinigal were able to participate in painting, decorating, carpentry, joinery and bricklaying. Christian Inglis-Hodge summed up his experience

*"TAFE was a great experience which allowed myself to gain experience about what the real world is like and what is expected of you. Rockingham TAFE was very supportive and professional, they allowed me to make a decision in whether or not I would desire to pursue a career in bricklaying or tiling. Bricklaying was very interesting and knowledgeable but not for me. This course and 'try a trade' was a great help to make a plan and decide what I am interested in doing in the near future.
